

1. The applicant represents all parties in interest and shall furnish material, do all the work, pay all costs and shall in a reasonable length of time restore the damaged portions of the highway to a condition similar or equal to that existing before the commencement of the described work, including seeding and sodding if necessary. Any disturbance such as sinking or lower of road and ditch shall be repaired 90 days after notification of the applicant. If not, then the Highway Commissioner shall hire contractor of choice to perform the work, which shall be paid by the applicant.
2. The proposed work shall be located and constructed to the satisfaction of the Highway Commissioner or his duly authorized representative. No revisions or additions shall be made to the proposed work on the right-of-way without the written permission of the Highway Commissioner.
3. The applicant, his successor or assigns, agrees to hold harmless the Township of Essex and its duly appointed agents and employees against any action for person injury or property damaged sustained by reason of the exercise of this permit.
4. This application will be used for Boring, Installing sleeves, trenching across all township roads and road ditches which installs any wires, tubing, sleeves, conduit, piping, culverts and concrete, steel or plastic boxes. No wooden bridges may be installed across any ditches as a permanent structure. Any temporary structure across any township road or road ditch must have a permit following all restrictions. The applicant shall not trim, cut in or in any way disturb any trees or shrubbery along the highways without the approval of the Highway/Road Commissioner or his duly authorized representative.
5. This permit is effect only insofar as the Road Districts has jurisdiction and does not presume to release the applicant from compliance with the provisions of any existing statutes or local regulations relating to the construction of such work.
6. The applicant affirms that the property lines shown on the attached sheet(s) are true and correct and bids and obligates him to perform the operation in accordance with the description and attached sketch and to abide by the policy regulations.
7. All constructions to be done according to the State of Illinois standard specifications for road and bridge construction. All materials used must comply with specifications designated by Road Commissioner. All upgrades to existing road shall meet specifications made by Road Commissioner.
8. Entrance shall be completed before any excavation or construction begins.
9. All inspections require 48hr notice.
10. New installation culverts will be 40' in length, _____ diameter. Any culvert 24" and under will have a cost of a minimum of \$2,000.00. Any culvert over 24" will cost a minimum of \$5,000.00. This will apply to 1 ditch and 1 crossing which is good for a maximum of 1 year from the entrance permit date. Boring or trenching under township roads will cost \$5,000.00 per trench.
11. Top of culvert pipe shall be a minimum of 10" lower than the center of the road with a minimum of 8" of cover on the top of the pipe. All haul road and crossings will be evaluated by Road Commissioner and applicant as stated in first restrictions. All ditch crossing shall have a

minimum of 4' cover from the top of the existing ditch. The minimum cover depth required by applicant is 48".

12. Storm water flow line and flow of water shall be maintained at all times so as not to interfere with adjacent property owners. If any adjustments are required, see 1st restriction.
13. Any court costs, lawyer fee or work fees that may accrue on the application will be paid by applicant.
14. All road and ditch crossings for new construction or repairs that are made using material such as rubber pads, foam blankets, tires, dirt, gravel or any material that allows equipment to cross on has to have a permit, visual inspections or written consent for restoration. All restoration must meet Road Commissioner approval or restriction 13 will apply. All road posting shall apply. A permit will be required to travel, transport, haul or cross any road with weight more than 5 tons. All hauling/transporting any equipment down any Essex Township Road has to have a permit or permission. To restore any road that may have to closed or altered shall be the responsibility of the permit holder and must apply to all state and local regulations. The permit holder is liable for all liabilities.
15. During construction traffic CA16 chips required for roads being used during hot weather at a cost to the permit holder. Paying Essex Township for CA16 chip and for applying them to roads marked as haul roads.
16. Repairs done to Haul roads will be paid to Essex Township as needed by Essex Township Road Commissioner.
17. All roads marked as Haul roads by permit holder will be A-1 resurfaced after all construction is done at the cost of permit holder. Gravel roads will be A-3 and dust control.
18. All roads must be properly marked as haul/transport roads with signage at every roadway entrance.

AGREEMENT: NOW: THEREFORE, in consideration of the mutual promise and covenants herein set forth, the parties, intending to be legally bound, agrees as follows:

_____ agrees to undertake the following activities in accordance with the terms of this agreement.

Pay a lump sum to Essex Township Road District for costs directly associated with the management and implementation of this agreement. Said payment shall be made directly to Essex Township Road District within 21 days of the signing of this document. Such payment shall be made by check or wire transfer.

Road District Management Fees \$20,000.00

As part of the management fees stated above Essex Township Road District shall provide a contact person 24hr/7 days a week assistance related to permit issues while working in the Essex Township Road District are. Said Management fees will also include all pipe and temporary driveway permit fees.
